Christianity is about faith, but it is not about blind faith.

Christianity makes a bold claim that there is life after death and an extraordinary claim like that must have extraordinary evidence.

The resurrection of Jesus provided the evidence.

Harvard University Law

... One year, Christian students challenged him to take his three volumes on the Laws of Legal Evidence and apply the principles to evidence for the resurrection of Christ...

It is impossible that the apostles "could have persisted in affirming the truths they had narrated...

...had not Jesus actually risen from the dead, and had they not known this fact as certainly as they knew any other fact."



Harvard University Law

Greenleaf concludes that the resurrection of Christ is one of the best-supported events in history according to the laws of legal evidence administered in courts of justice.

"Fellow Israelites, I can tell you confidently that the patriarch David died and was buried, and his tomb is here to this day. But he was a prophet and knew that God had promised him on oath that he would place one of his descendants on his throne.
